NDA 2025

The National Defense Authorization Act for Fiscal Year 2025 (NDA 2025) is a United States federal law which specifies the budget, expenditures, and policies of the U.S. Department of Defense (DOD) for fiscal year 2025. The bill passed the House on December 11, 2024. Please see attached chart regarding impacts on DoDEA.

- DoDEA district accreditation scores exceed the national average Index of Education Quality. Specifically, the 2022-2024 US average is 253 and DoDEA District's accreditations range from 317-372. The Europe South district, in which CNREURAFCENT installation schools (NS Rota, NAS Sigonella, NSA Naples, NSA Bahrain) are included, received a 370. Accreditation for each district is evaluated by Cognia every 5 years.
- Advance Placement (AP) 56% increase in participation and 136% increase in performance School Year 1017 to 2024.

NAEP Report Card

Fourth and eighth-grade students attending Department of Defense Education Activity (DoDEA) schools led the nation in scoring on the 2024 National Assessment of Educational Progress (NAEP) Reading and Mathematics Assessments.

- Notable improvements made in Math, with 4th grade moving from 27th to 1st place and 8th grade moving from 18th to 1st place.

Considering an Out of State School (College or University)?

Midwestern Higher Education Compact <https://www.mhec.org/>

Offers reduced tuition rates to students in 12 participating states for both public and private not-for-profit institutions through this reciprocity program.

New England Board of Higher Education <https://nebhe.org/>

Students are eligible for Tuition Break when enrolled in a degree program offered by a specific public college or university in another New England state. Approved degree programs for associate, bachelor's and graduate in 6 states.

Southern Regional Education Board <https://www.sreb.org/>

Students can enroll in out-of-state institutions and pay the institution's in-state tuition rates for more than 2,200 undergraduate and graduate programs in 16 states.

Western Undergraduate Exchange www.wiche.edu

Offers reduced nonresident tuition to residents in the West studying out-of-state at 160 public institutions in 16 states. Applicants must be resident of a WICHE state, apply to a participating institution and meet the institution's requirements .

EXTRA TIP: In addition to the regional agreements, some states have their own smaller reciprocity programs or offer flexibility when it comes to determining who qualifies for in-state tuition. Some of the arrangements apply to students from anywhere within a neighboring state; others extend only to students living in specific counties of the neighboring state or close to the state line.

ADDITIONAL TIPS:

- ⇒ Look to see what school the parent(s) or grandparent(s) attended for Alumni Legacy Programs or Waivers.
- ⇒ Look for school specific academic scholarships (on the school website) that are applied to out-of-state/nonresident tuition costs.

YELLOW RIBBON:

Can help you pay for higher out-of-state, private school, foreign school or graduate school tuition and fees that the Post 9/11 GI Bill doesn't cover.

The amount of money you receive varies by school, degree type, and the academic program you are interested in.

NDAA – Impact on DoDEA

Section	Title	Brief Summary
591	Advisory Committees for Department of Defense Domestic Dependent Schools	Converts DoDEA's domestic School Boards to School Advisory Councils and aligns DoDEA's domestic schools and incorporates the School Advisory Council structure already in place for the overseas DoDEA elementary and secondary schools. Improves parental participation.
592	Eligibility of Dependents of Certain Deceased Members of the Armed Forces for Enrollment in Department of Defense Domestic Dependent Elementary and Secondary Schools.	Expands enrollment eligibility for dependents of service members who died in certain situations (e.g., terrorist attacks, peacekeeping missions, or combat operations) for DoD domestic education programs.
593	Expansion of Eligibility for Virtual Programs Operated by Department of Defense Education Activity	Makes permanent where some supplemental virtual learning options for active-duty members families serving in the United States where DoDEA schools are not available.
594	Authorization For School Meal Programs at Department of Defense Dependent Schools	Permits the DoD to administer school meal programs in line with federal standards at both domestic and overseas schools.
595	Eligibility of Certain Dependents for Enrollment in Domestic Dependent Elementary and Secondary Schools.	Makes permanent that children of active-duty armed forces members may enroll in certain DoD schools on a space-available basis regardless of whether they live on military installations.
596	Staffing of Department of Defense Education Activity Schools to Maintain Maximum Student-to-Teacher Ratios	Restricts changes to the student-to-teacher ratios in DoD Education Activity schools, extending the mandate to the 2029-2030 academic year.

Fill in the quick pre-session questionnaire. Using this information, we will match you with the first available tutor best qualified to assist you.



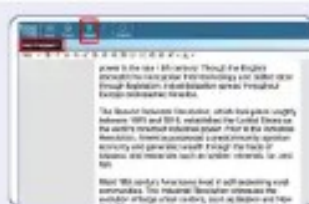
Step 3: Communicate

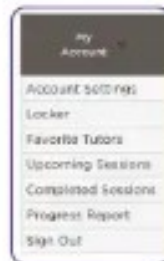
